As we embark on this new chapter, I am confident that under Mr. Potgieter's leadership, we will witness significant developments and advancements in our roads and building infrastructure.

His dedication to excellence and commitment to ensuring quality control will undoubtedly bring positive changes to our community. Mr. Potgieter, on behalf of the council, staff, and our constituents, we extend our heartfelt welcome to you.

With this said, I would like to give a summary update on the current major road projects that are ongoing or awarded:

- Consultancy Services for Road Rehabilitation
- Rehabilitation of Intersections (Phase 2)
- Routine Road Maintenance (Lot 1-4)
- Rehabilitation of Union Street (Phase 1)

The total value of these projects is approximately 25 million dollars of which approximately 10.5 million has been spent.

Upcoming road projects in the pipeline are:

- Resealing of Streets and Sidewalks
- Pothole Repairs
- Rehabilitation of Intersections
- Rehabilitation of Union Street Phase 2
- Repair of Sidewalks

These projects will cost the council an additional estimated amount of 25 million dollars once awarded and completed.

Council is well aware that we are a long way from having excellent roads in Walvis Bay, but we would like to assure our residents that we are prioritizing road infrastructure.

Before I conclude, I would like to inform the Council and the residents of my recent appointment as a member of the Regional Mayors Forum of the Covenant of Mayors in Sub-Saharan Africa.

The Covenant of Mayors is an international movement that brings together local governments committed to taking action on climate change and ensuring sustainable communities for their citizens. Being selected to join the Regional Mayors Forum is an incredible honor and a testament to our dedication to environmental sustainability and our town's remarkable achievements in this area.

This appointment holds significant implications for Walvis Bay as a town. By participating in the Regional Mayors Forum, I will have the opportunity to exchange ideas, best practices, and innovative solutions with other mayors from the region.

This engagement will equip me with valuable knowledge and insights, helping us address local challenges, specifically those related to climate change and

sustainable development. We can expect to implement new strategies and initiatives derived from this collaboration, putting us at the forefront of sustainable development in our region.
